YUMA COUNTY COMMISSIONERS March 31, 2022 Minutes¹

On March 31, 2022 at 8:00 a.m., the Yuma County Board of Commissioners met in regular session. Chairman Robin Wiley, Commissioner Trent Bushner, Commissioner Scott Weaver, and Administrator Andrea Calhoon were present throughout the day.

The Commissioners reviewed and signed accounts payable and discussed various meetings attended throughout the prior month.

Liquor License

At 8:15 a.m. Deputy County Clerk Nancy Wright presented an appeal letter and petition from Kirk Super's for the previously denied liquor license application. The Commissioners read and considered information presented. Commissioner Bushner moved to approve the retail liquor license as appealed based on the introduction of additional community comment and input from the Kirk area. Commissioner Weaver seconded the motion, which passed unanimously.

Road and Bridge

Road & Bridge Supervisor Tom Andersen, Blade Foreman Justin Lorimer, and Truck Foreman Jeremy Lund joined the meeting at 8:30 a.m. to provide department updates.

- Gravel Sale Andersen discussed a request from a citizen to purchase material from the Dreher
 pit to put in a spray plane runway in Kirk. The group discussed the policy for selling gravel to
 citizens and limits on the amount that can be removed and confirmed that the maximum
 allowable is 200 yards.
- Chip Seal Andersen confirmed that no chip seal projects were scheduled for this summer and that the fog coat on the Eckley Road is still planned for May.
- Staffing Andersen provided a report on the interviews conducted for department vacancies.
- Cutting Edges The group discussed the potential use of specialized cutting edges for washboards. Lorimer discussed the road grading strategy that would be deployed in the usage of the cutting edges and the potential impacts and challenges of usage. Lorimer proposed acquiring one set of cutting edges that would be shared by the blade team and used on a project basis. The group discussed the benefits of rotating the equipment around versus having one specifically trained operator to test the equipment effectiveness on behalf of the team. Commissioner Bushner moved to approve the purchase of one specialized cutting blade as requested. Commissioner Weaver seconded the motion. It passed by unanimous vote.
- Internal Position Transfers Andersen presented internal transfer requests for Allen Davisson,
 Rod Prather, Steven Nichley, and Peter Martinez. The group discussed the transfers with respect
 to the current salary structure. Commissioner Weaver moved to approve the internal transfer
 requests for job title change only as presented. Commissioner Bushner seconded the motion,
 which passed unanimously.
- Personal Leave Usage The group reviewed a report of personal leave and comp balances as well
 as the 2022 first quarter no-pay report. Personal leave usage policy was discussed and reviewed.
- Permits Andersen presented for approval a road access permit for Viaero Wireless to bore along County Road 13 and County Road RR for purposes of installing utility line. Commissioner Bushner

moved to approve the road access permit for Viaero Wireless as submitted. Commissioner Weaver seconded the motion. It passed by unanimous vote.

Executive Session – Commissioner Bushner moved to enter into executive session under CRS 24-6-402(4)(f) for personnel matters at 9:29 a.m. Commissioner Weaver seconded the motion. It passed by unanimous vote. Present for executive session were Chairman Wiley, Commissioner Bushner, Commissioner Weaver, Administrator Calhoon, Road & Bridge Supervisor Andersen, Blade Foreman Lorimer, Truck Foreman Lund, Finance Officer Carwin, and Finance Clerk Ritchey. Executive session ended at 9:51 a.m. No action was taken following executive session.

County Clerk, Bev Wenger

Yuma County Clerk and Recorder Bev Wenger joined the Commissioners at 10:30 a.m. to discuss current election progress and requirements. Wenger provided updates on election security measures, requirements, and pending legislation.

Human Services

The Board of County Commissioners convened as the Board of Social Services at 11:00 a.m. Human Services Director Kara Hoover, Eligibility Supervisor Dalene Rogers and Administrative Assistant Asalea Bencomo were present. Land Use

County Land Use Administrator Colten Yoast was heard at 2:30 p.m. to review Land Use and GIS Business.

- Pending Land Use Activity Yoast reported no land use hearings for the month of March and currently no applications received for consideration in the month of April.
- Land Use Code Yoast reported on land use code changes to be considered and reviewed by the Planning Commission at the next meeting.

- CAPP Report & Claim Review The Commissioners heard information on pending CAPP and workers' compensation claims.
- Signatures and Ratifications
 - Resolutions/Ordinances/Signatures:
 - Commissioner Weaver moved to approve signature on the Region 4 Opioid Council contract amendment with OMNI Institute pending approval by the Region 4 Opioid Council. Commissioner Bushner seconded the motion. It passed unanimously.
 - Commissioner Bushner moved to approve signature on Resolution 03-31-2022 A approving the abatement of uncollectable taxes as reported by the County Treasurer. Commissioner Weaver seconded the motion, which passed by unanimous vote.
 - Commissioner Bushner moved to approve the contribution of \$15,000 to the Republican River Water Conservation District River Restoration project manager costs to be shared with Kit Carson County. Commissioner Weaver seconded the motion, which passed unanimously.
 - Commissioner Bushner moved to rescind Resolution 08-30-2019 C related to the abatement of taxes on wind turbines manufactured in place. Commissioner Weaver seconded the motion. It passed by unanimous vote.
 - o Grant Updates:
 - The Commissioners reviewed information regarding pending and submitted grant applications including the Eckley Road chip seal, American Rescue Act funds, and the CDPHE recycling grant.
- Department Reports The Commissioners received and reviewed the March 2022 Veteran's Service Officer Report.
- Prior Meeting Follow-Up Finance and Compliance Clerk Brandi Ritchey provided project updates on the status of properties in Eckley. The group also discussed the status of a recent application to host a horse race at the Yuma County Fairgrounds.
- Correspondence Calhoon presented correspondence received since the last meeting including
 an update on Yuma County Ag Appreciation Week, a photography proposal for Yuma County Fair
 from Shelby K Marketing, a request to use portable bleachers from the fairgrounds by Rhonda

Commissioner Bushner moved to approve the purchase of a mobile workstation laptop and monitor as presented. Commissioner Weaver seconded the motion. It passed unanimously.
