October 31, 2022 Minutes¹

On October 31, 2022 at 8:00 a.m., the Yuma County Board of Commissioners met in regular session. Chairman Trent Bushner, Commissioner Scott Weaver, Commissioner Mike Leerar, and Finance Clerk Brandi Ritchey were present throughout the day.

The Commissioners reviewed and signed accounts payable and discussed various meetings attended throughout the prior month.

Liquor License

Deputy County Clerk Nancy Wright presented for signature the previously approved retail liquor license renewal for Millan Liquors, LLC and a new license for Kirk Supers. Commissioner Weaver moved to approve both Liquor Licenses as presented. Commissioner Leerar seconded the motion. It passed unanimously.

Road and Bridge

Road & Bridge Supervisor Tom Andersen joined the meeting at 8:30 a.m. to provide department updates.
