# YUMA COUNTY COMMISSIONERS December 30, 2022 Minutes<sup>1</sup>

On December 30, 2022 at 8:00 a.m., the Yuma County Board of Commissioners met in regular session. Chairman Trent Bushner, Commissioner Scott Weaver, Commissioner Mike Leerar, and Administrator Andrea Calhoon were present throughout the day.

The Commissioners reviewed and signed accounts payable and discussed various meetings attended throughout the prior month.

#### Liquor Licenses

Deputy County Clerk Nancy Wright joined the Commissioners at 8:15 a.m. to present for signature the previously approved retail liquor license renewal for Milan Liquors. The license was signed by Chairman Bushner.

### Road and Bridge

Road & Bridge Supervisor Tom Andersen and Blade Foreman Justin Lorimer joined the meeting at 8:30 a.m. to provide department updates.

- County Houses Andersen presented a recommendation for rent rates and lease terms for county-owned houses for blade operators in 2023. Commissioner Weaver moved to update County House rent rates to \$650/month for non-area operator renters and \$200/month for area operator renters effective July 1, 2023. Commissioner Leerar seconded the motion, which passed by unanimous vote.
- Equipment Sales Andersen presented an updated listing of unused equipment and a request for the equipment to be designated as surplus.
- CDL Truck Rental Andersen reported on the rental of Road & Bridge trucks by Northeastern Junior College for use in regional CDL Entry-Level Driver Training courses.
- Road Report Lorimer provided updates on current and future road projects including the
  completion of work on County Road 51 and the move to County Road G and 4 for the rest of this
  week. Next week's work will commence with approximately 4 miles of County Road 58. The
  group discussed recent efforts in road management due to inclement weather.

#### **Human Services**

The Board of County Commissioners convened as the Board of Social Services at 9:30 a.m. Bookkeeper Melanie Fisher and Human Services Director Kara Hoover were present. Detailed minutes of the Board of Social Services are maintained separately by the Department of Human Services. The Board of County Commissioners reconvened at 10:15 a.m.

#### County Sheriff, Todd Combs

Yuma County Sheriff Todd Combs joined the Commissioners at 10:30 a.m. to review 2023 budgetary information and operational planning. The Commissioners reviewed the 2023 budget approvals and requested an update on Sheriff Comb's plans to reopen the jail. The Yuma County Jail has been funded for full operations in 2023 including an 8% salary increase from 2022 levels and an increased starting wage including retention bonus structure identical to neighboring counties. The Commissioners requested

significant efforts toward recruitment and Sheriff Combs committed to substantial and active hiring practices with a follow-up meeting to be held in 3 months.

Commissioner Weaver moved to enter into executive session at 11:15 a.m. under CRS 24-6-402(4)(b) for legal advice on specific legal matters. Commissioner Leerar seconded the motion. It passed by unanimous vote. Present for executive session were Chairman Trent Bushner, Commissioner Scott Weaver, Commissioner Mike Leerar, Sheriff Todd Combs, Administrator Andrea Calhoon, and Finance Clerk Brandi Ritchey. Executive session ended at 11:55 a.m. No action was taken following executive session.

#### Land Use

County Land Use Administrator Greg Jones was heard at 1:00 p.m. to review Land Use and GIS business and conduct Land Use Hearings.

Commissioners to provide a presentation regarding the 2023 fee change proposal for the District. The Committee reviewed various fee structures and presented thought processes to-date.

## Emergency Management, Jake Rockwell

At 3:30 p.m. Yuma County Emergency Manager Jake Rockwell presented office and programmatic updates. Among topics discussed were recent adverse weather conditions, anticipated state-wide needs related to a recent influx of migrants, environmental elements, and recent reports submitted. Rockwell presented the bid for the I Am Responding dispatch program for local firefighters. Commissioner Weaver moved to ratify Rockwell's signature on the I Am Responding joint agreement with Washington County to acquire software to support first responder dispatching and communication. Commissioner Leerar seconded the motion, which passed unanimously.

#### County Coroner, Javan Jones

At 4:00 p.m. County Coroner-elect Javan Jones joined the Commissioners to provide legal and legislative updates for the Coroner's Office for 2023. Jones reported on recent statutory changes for Coroner salaries and work on private burial guidance for the Commissioners.

Administrator Andrea Calhoon reviewed calls, correspondence, and presented the following for discussion and action:

- Minutes The Commissioners reviewed the minutes from the previous BOCC meetings.
   Commissioner Weaver moved to approve the minutes from the December 15, 2022 regular meeting of the Board of County Commissioners. Commissioner Leerar seconded the motion, which passed unanimously.
- CAPP Report & Claim Review The Commissioners heard information on pending CAPP and workers' compensation claims.

    - Commissioner Weaver moved to approve signature on Resolution 12-15-2022 C adopting the 2022 supplemental budget. Commissioner Leerar seconded the motion. It passed by unanimous vote.
    - Commissioner Weaver moved to approve the Yuma County Secure Transport Licensure regulations and forms as presented. Commissioner Leerar seconded the motion, which passed unanimously.
    - Commissioner Weaver moved to approve signature on the Landfill Loan Agreement as presented. Commissioner Leerar seconded the motion. It passed by unanimous vote.
    - Commissioner Leerar moved to approve signature on the inmate boarding contract with the Kit Carson County Jail. Commissioner Weaver seconded the motion. It passed by unanimous vote.
  - Grant Updates:
    - The Commissioners reviewed information regarding pending and proposed grant applications. Commissioner Bushner signed the grant application documents for the County Clerk and Recorder's CESA Grant Award as previously discussed.
- Department Reports The Commissioners received various department reports including the December 2022 Veteran's Service Officer Report, an update on the administration of the Eastern Transportation Planning Region, and discussion of business undertaken by the 911 Authority Board. Commissioner Weaver moved to appoint Mike Leerar and Adam Gates to the 911

Authority Board to fill vacancies as of January 1, 2023. Commissioner Bushner seconded the motion, which passed unanimously.

- Prior Meeting Follow-Up The group discussed project updates on the status of properties in Eckley and the discussion of sale of county-owned properties.
  - Correspondence Calhoon presented correspondence received since the last meeting including updates on various board vacancies. Commissioner Weaver moved to appoint Bruce Mann, Dana Shaw, and Ron Blach to the Weed & Pest Board and Jessie Vance to the Eckley Cemetery Board as advertised. Commissioner Leerar seconded the motion. It passed by unanimous vote.
- CDL Testing Unit Calhoon provided updates on the status of the Yuma County CDL testing unit
  and the planning of an Entry Level Driver Training community education program recently
  established with Northeastern Junior College.
- IT Updates Calhoon presented updates on various IT-related topics including the status of the VOIP phone transition.
- Maintenance Updates Calhoon reported on various facilities maintenance topics. The group discussed the overall staffing model for the Facilities Maintenance team and goals for 2023.
- HR Updates Calhoon reported updates on county Human Resource topics including recruitment
  and retention and the status of year-end policy work. Commissioner Leerar moved to approve
  the 2023 salary schedule as presented. Commissioner Weaver seconded the motion, which
  passed unanimously.

Commissioner Weaver moved to approve the job description for the Fair Events Manager as presented. Commissioner Leerar seconded the motion. It passed by unanimous vote.

There being no further business, the meeting adjourned at 5:45 p.m. and the Commissioners entered into a 2023 budget work session. The next regular meetings of the Board of County Commissioners will be on January 10, 2023 and January 31, 2023.
