YUMA COUNTY COMMISSIONERS April 27, 2023 Minutes¹

On April 27 at 8:00 a.m., the Yuma County Board of Commissioners met in regular session. Chairman Scott Weaver, Commissioner Mike Leerar, Commissioner Adam Gates, and Finance Officer Sarah Carwin was present throughout the day.

The Commissioners initiated the meeting with the pledge of allegiance, reviewed and signed accounts payable, and discussed various meetings attended throughout the prior month.

Road and Bridge

Road & Bridge Supervisor Tom Andersen and Fleet Foreman Matt Martin joined the meeting at 8:33 a.m. to provide department updates.

- Permit To trench across road P for Brophy Commissioner Leerar moved to approve the Permit
 to trench across County Road P submitted by Brophy. Commissioner Gates seconded the
 motion, which passed unanimously.
- Blades Took delivery of two new JD blades this week. Matt moved the Fleet Intelligence units to the new blades.
- Fleet Intelligence Should have an update on the contract next week. Discussed the option of knowing when the blade is up or down. Tom will look into the cost on this feature.
- BW Partnership Road Update Finished the road construction on HH.2 and are waiting on county approval to take over the road from them. Tom will go look at the road and take pictures to present the approval of the county taking over the road.
- Road Report Finished 35 going by alpha flour. Sub grade will be done on CR 2 between X-Y, top
 coating on Monday. Started subgrade on Beacher Road between 13-19, pulling shoulders and
 putting base on it, should start later next week laying down. Today, we're laying down on L
 between 48-50.
- Staffing A grader operator is out and another county employee is filling in
- Fuel Contracted 80,000 gallons of fuel for All area shops through 4th quarter at \$3.04 and will be on a bi-monthly route Stratton Coop
- Other Commissioner Leerar asked Tom to check on CR RR. Commissioner Gates followed up on Truck tarping complaint. Tom explained there should be no reason not to trap and this has been addressed with the Trucking Foreman. Tom will be bringing in information for Aageson on the Mining Position. Discussion was had on hauling material from the Mek1 pit. Commissioner Weaver asked about the material at the track at fairgrounds. It was decided that 4 inches of base would be pulled out and make it at grade with sand. Two piles of material would be left at the fairgrounds one for base and one for sand. The Rodeo Area is looking great! There was discussion about R&B Time Off and lost work time. Discussion on writing a department policy for requesting time off request and approval process. Commissioner Leerar mentioned that by the Yuma Shop between R&B & W&P building has grass that was parked or drove on asked to not park on it. Still working on hauling material to Landfill. Job Openings are kind of stagnant needing to find some new ways to get positions filled.

Larry then wanted to discuss the matter of County Road 9 and he would like the Commissioner's to decided one way or another if that will be a road or not. After some research there was minutes that notated conversation with Bruce Mann & Larry Terrell in Spring of 2022 regarding the matter. The Commissioner's would first like to verify if the road has been abandoned. If the road has been abandoned then a correspondence would need to go to both parties that the section line easement would needed be used for the property line dispute.

Yuma County Treasurer

County Treasurer, Chrystal Hammond was heard at 10:40 a.m. to give update on Omimex Energy Inc. One issue for taxation is that the inventory on site as of January 1, 2023 will be taxed for the entire year of 2023. The Assessor's Office won't be able to do the inventory until late Summer. Chrystal's office could go out and do the inventory to help the Assessor's office, but would like to explore other contacts that may have the information. There was discussion that maybe COGCC or other local Oil & Gas companies might be able to help. She has been working with the Attorney Paul on how to proceed. Paul is going to be in contact with COGCC and Steve in Philips County.

IT IS UNDERSTOOD that the permittee will cause the installation at no expense whatsoever to Yuma County and that the permittee will own and maintain the same after installation. Where the installation crosses the roadway, it shall be encased in a pipe of larger diameter and the crossing shall be as perpendicular to the roadway as physically possible. However, an open cut shall be allowed up to the edge of the surface portion of the roadway. All installations shall be installed by the method of boring or jacking through beneath the road surface, unless prior arrangements have been made and approved by the Road Supervisor. No water shall be used in the boring, and no tunneling shall be permitted.
 The above line shall be installed beneath the surface of the right-of-way at a minimum depth of 48 inches. Unless the right-of-way ditch is full of dirt, permittee will need an additional depth of 48 inches. The disturbed portion of the roadway shall be restored to its original condition. The backfilling shall be made in 6" lifts and mechanically tamped and packed. The last 12" of backfill shall be of stable granular material such as crushed rock or gravel.
Where installation crosses any ditches, canals, or water carrying structures, where possible, it shall be pushed through and beneath in a pipe of larger diameter, thereby eliminating the necessity of trenching. In no case shall the flow of water ever be impaired or interrupted.
This work must be accomplished in accordance with accepted good practices and conform to the recommendations of the national electric safety code and to such Colorado statutes as are applicable.
SPECIALPROVISIONS
This work shall be completed within 30 alw from the above date. No work shall be allowed on Saturdays or Sundays. No open trench permitted in traveled roadways after dark unless otherwise specified in the Special Provisions. Permittee must contact the Road Supervisor between one and two business days before the work begins. The permittee shall maintain the installation at all times and agrees to hold Yuma County, the agencies thereof, and their officers and employees harmless from any and all loss and damage which may arise out of or be connected with the installation, maintenance, alteration, removal, and presence of the installation herein referred to or any work or facility connected therewith, within the area covered by this permit.

Permittee shall be required to shut off lines and remove all combustible materials from the roadway right-of-way when requested to do so by the County of Yuma because of necessary roadway construction or maintenance operations. If the County so requires, permittee shall mark this installation with markers acceptable to the County of Yuma at the locations designated by the County of Yuma.

Permits involving encroachment on the national System of Interstate Defense Highways require concurrence by the U.S. Bureau of Public Roads prior to the issuance of a permit by the County of Yuma.

The traveling public must be protected during this installation with proper warning signs or signals both day and night. Warning signs and signals shall be installed by and at the expense of the permittee and in accordance with directions given by the Road Supervisor or his subordinate.

In the event any changes are made to this roadway in the future that would necessitate removal for relocation of this installation, permittee will do so promptly at his own expense upon written request from the County of Yuma, State of Colorado. The County will not be responsible for any damage that may result in the maintenance of the roadway to installation placed inside Yuma county right-of-waylimits.

\$50.00 for boring under each dirt or gravel road

\$75.00 for boring under each dirt or gravel road across an intersection

\$1,000 for trenching across each dirt or gravel road

- \$500 will be refunded after six months if there are no additional repairs needed on the road. Should additional repairs be done by the road department, the \$500.00 deposit will be reduced by the cost of the repairs.
- Trenching across or boring under asphalt roads may be considered under special circumstances by the BOCC.

Right-of-Way Impacts

\$50.00 for ditching or digging in the right-of-way

- \$ 0.50 per rod for laying telephone line in right-of-way (one rod equals 16.5 feet)
- Special circumstances may cause additional fees which will be considered on a case-by-case basis and approved by the BOCC.
- There may be a combination of the above fees, depending on the project.
- The Yuma County Road and Bridge Department will evaluate projects when the application is received. The
 applicant will be notified of the required fees. The fees are to be paid prior to the approval of the permit.
