In order for pay to be issued effectively and efficiently, employees need to submit timesheets as quickly as possible following the end of a pay period. Supervisorapproved timesheets are due to the Finance Office by 9:00 am the next business day following the

end of a pay period. This allows time for processing in the Finance Office and time to make all necessary banking notifications, which are due two days before pay day.
