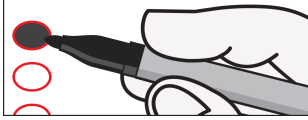

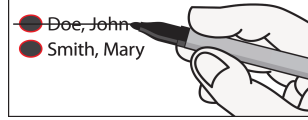
**INSTRUCTIONS TO VOTERS:**

**Optional write-in**



To vote for a qualified write-in candidate, write the person's name in the blank space provided and FILL IN THE OVAL to the left.

**WARNING:** Any person who, by use of force or other means, unduly influences an eligible elector to vote in any particular manner or to refrain from voting, or who falsely makes, alters, forges or counterfeits any mail ballot before or after it has been cast, or who destroys, defaces, mutilates, or tampers with a ballot is subject, upon conviction, to imprisonment, or to a fine, or both. **Holyoke School District RE-1J Ballot Issue 5A**

WITHOUT CREATING ANY NEW TAX OR INCREASING ANY CURRENT TAX FOR HOLYOKE SCHOOL DISTRICT NO. RE-1J, SHALL THE DISTRICT'S VOTER-APPROVED OVERRIDE MILL LEVY OF SEVEN (7) MILLS, WHICH IS SCHEDULED TO EXPIRE AFTER COLLECTION YEAR 2020, BE EXTENDED FOR AN ADDITIONAL FIVE YEARS (TO EXPIRE AFTER COLLECTION YEAR 2025), TO FUND, AMONG OTHER THINGS,

- MAINTENANCE OF EXISTING FACILITIES,
- QUALITY INSTRUCTIONAL AND INFORMATIONAL TECHNOLOGY,
- CURRENT INSTRUCTIONAL SUPPLIES AND MATERIALS,

**Sandhills Ground Water Management District Ballot Issue 6A**
