YUMA COUNTY COMMISSIONERS April 30, 2021 Minutes¹

On April 30, 2021 at 8:00 a.m., the Yuma County Board of Commissioners met in regular session. Chairman Trent Bushner, Commissioner Robin Wiley, Commissioner Scott Weaver, and Administrator Andrea Calhoon were present throughout the day. The meeting was open to the public via teleconference due to the COVID19.

The Commissioners reviewed and signed accounts payable and discussed various meetings attended throughout the prior month.

Financial Reports

Finance Officer Sarah Carwin joined the meeting at 8:30 a.m. to provide financial updates and reports. Carwin presented financial reports for the WY Communications Center, titles for newly purchased and traded trucks for the Road & Bridge Department, capital expenditures to date, various fair financial topics, and new bank signature cards for Bank of Colorado accounts. Commissioner Weaver moved to approve 2021 Yuma County Fair Ticket Pricing as approved. Commissioner Wiley seconded the motion. It passed unanimously.

Commissioner Wiley moved to approve the 2021 Yuma County Fair night show contract with Kinnon Entertainment as presented. Commissioner Weaver seconded the motion, which passed by unanimous vote.

Commissioner Weaver moved to approve the 2021 Yuma County PRCA Rodeo production contract with Mike Cervi Championship Rodeo Company LLC as presented. Commissioner Wiley seconded the motion. It passed unanimously.

Commissioner Weaver moved to approve the 2021 Yuma County Rodeo music contract with Hawkeye Sound as presented. Commissioner Wiley seconded the motion. It passed by unanimous vote.

The 2021 Yuma County Rodeo big screen and video production contract with Frost View Productions was tabled for further clarification on contract language and will be reviewed at an upcoming meeting.

Human Services

The Board of County Commissioners convened as the Board of Social Services at 9:00 a.m. Human Services Director Kara Hoover, Child Welfare and Adult Protection Supervisor Hollie Hillman, and Eligibility Supervisor Dalene Rogers, and Receptionist Robin Stich were present. Detailed minutes of the Board of Social Services are maintained separately by the Department of Human Services.

The Board of County Commissioners reconvened at 10:00 a.m.

Road and Bridge

Road & Bridge Supervisor Tom Andersen joined the meeting at 10:00 a.m. to provide department updates. Also in attendance were Blade Foreman Justin Lorimer and Truck Foreman Jeremy Lund.

- 5 Year Plan Andersen provided updates on the progress in developing a 5-year capital plan.
- Storm Damage Assessment Andersen, Lorimer, and Lund provided updates on the assessment of storm damage following heavy rains in northwest Yuma County earlier this week. The group discussed potential FEMA disaster small project requirements and documentation and planning efforts related to response and repair.
- PubWorks Refresh Andersen provided an update on progress made by Parts Clerk Damian Rock to refresh
 the PubWorks system and data and the anticipated growth and productivity in the position. Commissioner
 Weaver moved to approve the salary authorization request for Damian Rock as presented. Commissioner
 Wiley seconded the motion. It passed by unanimous vote.

- New Hires Andersen presented salary authorizations for new hires Oscar Olivas, Travis Wiltfang, and Clinton Jesse. Commissioner Wiley moved to approve the salary authorizations for new hire truck driver Oscar Luna, new hire blade operator Travis Wiltfang, and new hire maintenance worker Clinton Jesse as presented. Commissioner Weaver seconded the motion, which passed unanimously.
- Permits Andersen presented for approval one road access permit. Commissioner Weaver moved to
 approve the road access permit for Tris-State to trench a utility line under County Road E into the North
 Yuma Substation. Commissioner Wiley seconded the motion, which passed unanimously.
- Truck Bids The Commissioners reviewed bids for the trucks posted for sale. Two bids were received for the 1999 Kenworth, both were rejected for not meeting the reserve. Commissioner Wiley moved to accept the bid from Cornerstone Farms for the purchase of the three Kenworth T800s for a total of \$117,000.
 Commissioner Bushner seconded the motion. The motion passed by unanimous vote with Commissioner Weaver abstaining.

Beer Garden Proposal, Yuma County Fair Board

At 11:00 am the Commissioners were joined by Baylor Buck, Jed Gleghorn, and Micah Seyler of the Yuma County Fair Board to hear a proposal on the establishment and management of a beer garden during the Yuma County Fair. Also in attendance were County Sheriff Todd Combs and Undersheriff Larry Gilliland. The group discussed the weighted relationship between potential revenue generation and security concerns. The group presented a plan in which a vendor would provide the beer garden administration and liability for issues would be covered under the liability coverage of the vendor. The group discussed the process for selecting and identifying a vendor to comply with County requirements. The group also discussed liquor licensing requirements.

Commissioner Wiley expressed concern over the impact of a County-sponsored alcohol event and the appropriateness of County-sponsored alcohol at what is intended to be a family event. Commissioner Weaver inquired about how control would be ensured that folks were not in the beer garden during the concert and hearing the concert without purchasing concert tickets. Additionally, Commissioner Weaver inquired about what work had been done to address community concerns that have been raised over the implementation of a beer garden and what work is being planned to hear, respond to, and address community concerns over a beer garden.

The group agreed that no alcohol would be permitted on the remaining fairgrounds facilities during beer garden operations. Discussion was held regarding alcohol consumption in the infield, RV parking, and in other areas in light of this policy and how security and law enforcement would address alcohol presence and consumption in other areas of the fairgrounds in light of this program. Sheriff Combs and Undersheriff Gilliland expressed concern over inconsistent alcohol policies and encouraged the development of consistent policies that can be enforced by security and law enforcement alike regardless of timing or location.

Commissioner Bushner expressed the importance of liability mitigation with overserving and inappropriately serving patrons. Commissioner Bushner also expressed the importance of limits on serving and refusal to serve patrons to arrive already under the influence and the necessary strength of policy in serving of alcohol.

Commissioner Weaver asked the group what updates and improvements have been made between prior proposals and this proposal. Gleghorn reported that more discussions have occurred as a fair board this time. Commissioner Weaver expressed the importance of fully vetting the plan and program ahead of a formal decision and the necessity of thorough assessment in order for the Commissioners to have a comprehensive understanding and plan before final decision.

The conversation was tabled for further information, discussion, and evaluation and will be re-addressed at an upcoming meeting. A meeting to receive public comment on the proposal was scheduled for May 14, 2021 at 3:00 p.m.



Land Use

Land Use Administrator Colten Yoast was heard at 1:00 p.m. to review Land Use and GIS business and conduct Land Use Hearings.

- Land Use Hearings Land use hearings opened at 1:02 p.m. Yoast presented the following for signature.

Land Use Hearings closed at 1:15 p.m.

Commissioner Weaver moved to approve Resolution 04-30-2021 C approving exemption from subdivision EFS 0421-05 for John McMurphy to divide 2 acres, more or less, from 160 acres, more or less, located in the SW ¼ of Sec 32, T2N, R44W for purpose of resale. Commissioner Wiley seconded the motion. It passed unanimously.

Commissioner Weaver moved to approve Resolution 04-30-2021 D approving Major Land Use permit DEV 04211-01 for Yuma County Road & Bridge to open a gravel pit at the corner of Highway 59 and County Road 13 in Section 25, T3S, R48W. Commissioner Wiley seconded the motion. It passed unanimously.

Commissioner Wiley moved to approve signature on Resolution 04-30-2021 E approving the updated site plan for the construction of a 25-kw wind turbine approved through Resolution 03-14/2019 A. Commissioner Weaver seconded the motion, which passed by unanimous vote.

- Land Use Applications Yoast reported the expected Major Land Use permit for the construction of an anaerobic digester plant at the May hearings. Also expected for may are one major land use permit for a new substation and on exemption from subdivision. Commissioner Wiley moved to sign the consulting agreement with American Environmental Consultants LLC for provision of environmental engineering consulting services related to a pending land use application. Commissioner Weaver seconded the motion. It passed by unanimous vote.
- Land Use Code Yoast reported updates on research conducted regarding a mobile home moved into Yuma
 County and compliance with existing land use code.

GIS

Current Projects – Yoast reported on various GIS topics including the migration of the online map server.

Xcel Colorado Power Pathway, Greg Brophy and Lucas McConnell

At 2:00 p.m. the Commissioners heard a presentation from Lucas McConnell and Greg Brophy of Xcel Energy regarding the planned Colorado Power Pathway. Brophy reviewed the overall project of approximately 560 miles of high-capacity transmission lines planned to make a loop through multiple eastern Colorado counties. The group discussed the power and energy production future of Yuma County and the region and the potential long-term goals for energy production and transmission in the area. The Commissioners inquired as to the projected timeline for various project components. Further information will be available as the project progresses and nears permit application.



Yuma County Water Authority Public Improvement District

At 3:30 p.m. the Commissioners adjourned and convened as the Yuma County Water Authority Public Improvement District Board. Minutes for the Yuma County Water Authority Public Improvement District are kept separately.

 - Commissioner Wiley moved to approve Resolution 04-30-2021 B Approving the 2021 Northeast Regional Multi-Jurisdictional Hazard Mitigation Plan Update. Commissioner Weaver seconded the motion. It passed by unanimous vote.

The permittee shall maintain the installation at all times and agrees to hold Yuma County, the agencies thereof, and their officers and employees harmless from any and all loss and damage which may arise out of or be connected with the installation, maintenance, alteration, removal, and presence of the installation herein referred to or any work or facility connected therewith, within the area covered by this permit.

Permittee shall be required to shut off lines and remove all combustible materials from the roadway right-of-way when requested to do so by the County of Yuma because of necessary roadway construction or maintenance operations. If the County so requires, permittee shall mark this installation with markers acceptable to the County of Yuma at the locations designated by the County of Yuma.

Permits involving encroachment on the national System of Interstate Defense Highways require concurrence by the U.S. Bureau of Public Roads prior to the issuance of a permit by the County of Yuma.

The traveling public must be protected during this installation with proper warning signs or signals both day and night. Warning signs and signals shall be installed by and at the expense of the permittee and in accordance with directions given by the Road Supervisor or his subordinate.

In the event any changes are made to this roadway in the future that would necessitate removal for relocation of this installation, permittee will do so promptly at his own expense upon written request from the County of Yuma, State of Colorado. The County will not be responsible for any damage that may result in the maintenance of the roadway to installation placed inside Yuma county right-of-way limits.

\$1,000 for trenching across each dirt or gravel road

- \$500 will be refunded after six months if there are no additional repairs needed on the road. Should additional repairs be done by the road department, the \$500.00 deposit will be reduced by the cost of the repairs.
- Trenching across or boring under asphalt roads may be considered under special circumstances by the BOCC.

Right-of-Way Impacts

\$50.00 for ditching or digging in the right-of-way

- \$ 0.50 per rod for laying telephone line in right-of-way (one rod equals 16.5 feet)
- Special circumstances may cause additional fees which will be considered on a case-by-case basis and approved by the BOCC.
- There may be a combination of the above fees, depending on the project.
- The Yuma County Road and Bridge Department will evaluate projects when the application is received. The applicant will be notified of the required fees. The fees are to be paid prior to the approval of the permit.


