YUMA COUNTY COMMISSIONERS May 16, 2022 Minutes¹

On May 16, 2022 at 8:00 a.m., the Yuma County Board of Commissioners met in regular session. Chairman Robin Wiley, Commissioner Trent Bushner, Commissioner Scott Weaver, and Administrator Andrea Calhoon were present throughout the day.

The Commissioners reviewed and signed accounts payable and discussed various meetings attended throughout the prior month.

Human Services

The Board of County Commissioners convened as the Board of Social Services at 8:30 a.m. Human Services Director Kara Hoover, Eligibility Supervisor Dalene Rogers, Bookkeeper Melanie Fisher, new Eligibility Technician Molly Brug, and Administrative Assistant Asalia Bencomo were present. Detailed minutes of the Board of Social Services are maintained separately by the Department of Human Services. The Board of County Commissioners reconvened at 9:05 a.m.

Yuma County Water Authority Public Improvement District

At 9:10 a.m. the Commissioners adjourned and convened as the Yuma County Water Authority Public Improvement District Board. Minutes for the Yuma County Water Authority Public Improvement District are kept separately.

Road and Bridge

Road & Bridge Supervisor Tom Andersen, Blade Foreman Justin Lorimer, and Truck Foreman Jeremy Lund joined the meeting at 9:30 a.m. to provide department updates.

- Financials Andersen presented financial reports and operational reports of equipment usage for consideration. The group discussed various expense items including utilities and fuel and discussed the projection of expenditure over the remaining course of the year.
- Gravel Sale Andersen presented a request for gravel purchase of 200 yards from the Deterding pit for \$9.00 per yard for personal use. Commissioner Weaver moved to approve the sale of 200 yards of Deterding material to Jed Schneider for \$9.00 per yard as requested. Commissioner Bushner seconded the motion, which passed unanimously.
- Landfill Work Andersen reported on material usage and time spent improving a road inside the Yuma County Landfill.
- Idalia House Andersen reported on the lease of the Idalia House to a Road & Bridge mechanic.
 The lease will be reviewed and considered during the Administrator's Report. Terms of the lease including pets and pet deposits were reviewed.
- Eckley Road The agreement for the fog coat of the Eckley Road, scheduled for later this month by Cobitco for a total of \$61,803 including materials and application was presented. Commissioner Weaver moved to approve signature on the contract with Cobitco for fog coat of the Eckley Road in May of 2022 for a total of \$61,803 including materials and application. Commissioner Bushner seconded the motion, which passed unanimously.
- Pickup pricing Lund presented pricing for pickups requested for purchase in Spring of 2023.
 Commissioner Weaver moved to approve the purchase of three Ford pickups as presented for

delivery in 2023 as presented. Commissioner Bushner seconded the motion. It passed by unanimous vote.

- Truck Report Lund provided a report on the delivery of the remaining 2022 trucks ordered. Lund reported the trucks are built and are being finalized for delivery later this summer.
- Road Issues Lorimer provided road updates including issues on County Road 26. The group discussed the blade rotation and strategy for CR 26 west of the church at Vernon.
- Mower Pricing Andersen presented pricing for the purchase of new mowers from Central Plains Equipment. The Commissioners took the pricing under advisement for the 2023 budget.

Public Comment

Mr. Robert West was heard at 10:30 a.m. to issue public comment on the efficacy of investigation occurring in the 13th Judicial District Attorney's Office and to request the Commissioners require a Wraybased, Wray-exclusive investigator in response to the additional funding request issued by the District Attorney's Office for the 2022 Fiscal Year.

Mr. West requested information regarding the status of mental health diversion programs through Centennial Mental Health and issued the opinion that an increase in active prosecution efforts is necessary in Yuma County. West provided various statistical data sets to the Commissioners. Mr. West expressed appreciation and respect for the work of the Yuma County Jail and Sergeant Joe Wells for their efforts in professionally and effectively accommodating mental health issues presenting through the criminal justice system in Yuma County.

13th Judicial District Attorney, Travis Sides

District Attorney of the 13th Judicial District Travis Sides joined the Commissioners at 10:35 a.m. to provide office updates and discuss funding. Sides provided updates on casework and case disposition in Yuma County since his last meeting with the Commissioners. Sides reported approximately 55 felony cases in Yuma County in 2021 and almost 35 so far this year. Sides did note a corresponding decrease in misdemeanor cases in the area. Also provided were updates on staffing for Yuma County as well as staffing for the office overall.

Executive Session

At 11:30 a.m. Commissioner Weaver moved to enter into executive session under CRS 24-6-402(4)(f) for Personnel to conduct an exit interview. Commissioner Bushner seconded the motion. It passed by unanimous vote. Present for executive session were Chairman Robin Wiley, Commissioner Trent Bushner, Commissioner Scott Weaver, Land Use Administrator Colten Yoast, and Finance and Compliance Clerk Brandi Ritchey. Executive session ended at 11:50 a.m. No action was taken following executive session.

Land Use

County Land Use Administrator Colten Yoast was heard at 1:00 p.m. to review Land Use and GIS Business.

- Pending Land Use Activity Yoast reported two land use hearings for the month of May; one exemption from subdivision and one hearing on updates to land use code.
- Renewable Energy Meetings Yoast provided updates on recent informational meetings with renewable energy companies including NextERA and ENGIE.
- Staffing Yoast provided updates on the planning and transition for the upcoming staffing changes in his office.

Niyol Solar, NextERA Energy

Jennifer Herron, Chris Haas, and Natalie Graves of NextERA presented information and answered questions regarding the proposed 200MW solar project, which is anticipated to begin permitting this summer or fall and break ground in the third quarter of 2024.

At 3:00 p.m. Yuma County Treasurer Chrystal Hammond met with the Commissioners to provide office updates. Among topics discussed were the current investment market, status of Yuma County investments, and the future protocols for investing County funds.
