# YUMA COUNTY COMMISSIONERS January 10, 2023 Minutes<sup>1</sup>

On January 10, 2023 at 8:00 a.m., the Yuma County Board of Commissioners met in regular session. Chairman Trent Bushner, Commissioner Scott Weaver, Commissioner Mike Leerar, Commissioner Adam Gates, and Administrator Andrea Calhoon were present throughout the day.

The Commissioners reviewed and signed accounts payable and discussed various meetings attended throughout the prior month.

#### Road and Bridge

Road & Bridge Blade Foreman Justin Lorimer joined the meeting at 8:30 a.m. to provide department updates.

- Equipment Sales Lorimer reported on the previously approved sale of the D7 Dozer.
- Snow Removal Lorimer provided updates on snow removal efforts following recent snow storms. Lorimer reported that all roads have been opened up and that current work is focusing on widening out passages through large drifts. The group discussed public feedback on snow removal efforts and Lorimer reported on changes to operational strategies for future similar weather events.
- Road Report Lorimer discussed snow removal efforts on County Road 37 that has significant
  drifting and efforts to negotiate the piling of snow on private property.

#### <u>Swearing-In Ceremony</u>

The Commissioners recessed at 9:00 a.m. for the conduction of the annual swearing-in ceremony of County Officials.

#### County Sheriff, Todd Combs

Yuma County Sheriff Todd Combs joined the Commissioners at 9:30 a.m. to review the 2023 Eckley Law Enforcement contract. Combs expressed concern over code enforcement responsibilities included in the contract and the group discussed the structural responsibilities under the contract and the contract value. The Commissioners approved signature on the agreement pending negotiation of removal of any code enforcement requirements.

#### County Treasurer, Chrystal Hammond

At 10:00 a.m. County Treasurer Chrystal Hammond joined the Commissioners to review Office business and present the annual investment authorization and authorized bank signatories for 2023. Hammond presented the semi-annual investment report and reviewed the County investment policy. The Commissioners reviewed and approved the Treasurer's semi-annual report and reviewed the annual uncollectable tax listing.

Commissioner Leerar moved to approve signature on Resolution 1-10-2023 D Authorizing the Yuma County Treasurer to Deposit and Invest Funds. Commissioner Gates seconded the motion. It passed by unanimous vote.

Commissioner Leerar moved to approve signature on Resolution 1-10-2023 E Approving Authorized Signors on All Accounts. Commissioner Gates seconded the motion, which passed unanimously.

Commissioner Leerar moved to approve signature on Resolution 1-10-2023 F Approving Removal of Uncollectable Taxes from the Tax Roll. Commissioner Gates seconded the motion. It passed by unanimous vote.

#### Rural Jumpstart Program, Morgan Vankat

Morgan Vankat of the Colorado Office of Economic Development and International Trade joined the Commissioners at 1:00 p.m. to provide an overview of the Rural Jumpstart Program. Also present was Yuma County Economic Development Director Shelby Clark. Vankat presented an outline of the Rural Jumpstart program including program requirements and next steps for implementation in Yuma County. The Commissioners issued clarifying questions and took the information under advisement.

Administrator Andrea Calhoon reviewed calls, correspondence, and presented the following for discussion and action:

- Minutes The Commissioners reviewed the minutes from the previous BOCC meetings.
   Commissioner Leerar moved to approve the minutes from the December 31, 2022 regular meeting of the Board of County Commissioners. Commissioner Gates seconded the motion, which passed unanimously.
- CAPP Report & Claim Review The Commissioners heard information on pending CAPP and workers' compensation claims.

Commissioner Gates moved to approve signature on the updated Yuma County Emergency Operations Plan as presented. Commissioner Leerar seconded the motion, which passed by unanimous vote.

Commissioner Gates moved to approve the consulting agreement with Sun Daisy Consulting for support in reviewing renewable energy land use applications. Commissioner Leerar seconded the motion, which passed unanimously.

- Prior Meeting Follow-Up The group discussed project updates on the status of properties in Eckley and the discussion of sale of county-owned properties.
- Correspondence Calhoon presented correspondence received since the last meeting including updates on various board vacancies. The Commissioners set upcoming meeting dates of January 30, February 14 and 28, March 14 and 31, April 17 and 27, May 16 and 26, and June 14 and 30.
- CDL Testing Unit Calhoon provided updates on the status of the Yuma County CDL testing unit and the planning of an Entry Level Driver Training community education program recently established with Northeastern Junior College.
- IT Updates Calhoon presented updates on various IT-related topics including the status of the VOIP phone transition.
- Maintenance Updates Calhoon reported on various facilities maintenance topics. The group discussed the overall staffing model for the Facilities Maintenance team and goals for 2023. The group also reviewed fairgrounds improvements and strategic planning. Commissioner Gates moved to approve the bid from Kinnon Entertainment for the installation of additional audio equipment at the Yuma County Fairgrounds. Commissioner Leerar seconded the motion. It passed by unanimous vote.
- HR Updates Calhoon reported updates on county Human Resource topics including recruitment and retention and the status of year-end policy work.

At 4:10 p.m. Commissioner Leerar moved to enter into executive session under CRS 24-6-402(4)(b) for legal advice on specific legal matters. Commissioner Gates seconded the motion, which passed unanimously. Present for executive session were Chairman Scott Weaver, Commissioner Mike Leerar, Commissioner Adam Gates, and Administrator Andrea Calhoon. Executive session ended at 4:40 p.m. No action was taken following executive session.

There being no further business, the meeting adjourned at 5:15 p.m. The next regular meetings of the Board of County Commissioners will be on January 31, 2023 and February 14, 2023.

#### Official Bonds

Pursuant to Colorado Revised Statues, Section 24-13-105 the Yuma County Board of County Commissioners is satisfied that purchased crime insurance coverage meets the sufficiency of the official bond requirements of the County Commissioners C.R.S. 30-10-311, 312, and 313, Clerk and Recorder C.R.S. 30-10-401(2), Registrar of Titles C.R.S. 38-36-109 and 110, Sheriff C.R.S. 30-10-501(2), Coroner C.R.S. 30-10-601(b)(1.5), Treasurer 30-10-701(2), Public Trustee 38-37-102(4) and County Assessor 30-10-801(2); and approves and authorizes the purchase of insurance coverage in lieu of bonds of the respective County Officials.

#### **Administration Organization**

The County Administrator and/or Finance Officer may use the Chairman of the Board's signature stamp for emergency checks with authorization of the Chairman.

The Yuma County Administrator is designated to prepare and present the 2024 budget draft to the Board of County Commissioners on or before October 15, 2023 and the 2024 final budget on or before December 15, 2023.

The official posting location for meeting dates, agendas, public notices, and information relating to Commissioner activities shall be the bulletin board located outside the Commissioners' chambers in the Yuma County Courthouse.

The Yuma Pioneer is designated as THE official newspaper for Yuma County for 2023 and the Wray Gazette is designated an official newspaper for Yuma County. Fifty-two cents (\$.52) per mile is established as the mileage reimbursement rate for 2023 for Yuma County. Let it be known that this may be changed by the Board at any time during the year.

# A RESOLUTION TRANSFERRING \$29,412.50 FROM THE YUMA COUNTY WATER AUTHORITY FUND 10 TO THE GENERAL FUND 1

WHEREAS, Surplus fund balance and revenues in the Water Authority Fund 10 are available and will be used for this interfund transfer, and;

WHEREAS, the Board of County Commissioners purchased Soehner water rights on December 30, 2009 in the amount of \$739,469.96, and;

**WHEREAS**, Soehner water rights were leased to the Republican River Water Conservation District in 2022 producing \$29,412.50 in revenue, and;

WHEREAS, the Board of County Commissioners are the only entity that held interest in the Soehner Water rights, therefore it is deeded the lease revenue should be transferred to the Yuma County General Fund, and;

WHEREAS, this transfer is in the amount of revenue received for leasing the Soehner water rights in 2022;

**NOW, THEREFORE, BE IT RESOLVED**, the Commissioners of Yuma County, State of Colorado, approve the transfer of twenty-nine thousand four hundred twelve dollars and fifty cents from the Yuma County Water Authority Fund 10 to the Yuma County General Fund 1.

#### A RESOLUTION AUTHORIZING THE YUMA COUNTY TREASURER TO DEPOSIT AND INVEST FUNDS

WHEREAS, the County of Yuma, State of Colorado is charged with the responsibility of depositing public funds which come into its possession; and

WHEREAS, CRS 30-10-708 mandates a written resolution setting forth eligible financial institutions in which the Treasurer shall deposit funds and monies of whatever kind that may come into the Treasurer's possession; and

WHEREAS, Colorado Revised Statutes, Sections 11-10.5-101 to 11-10.5-111 and Sections 11-47-101 to 11-47-120 requires the deposit of public funds and monies in eligible state and national banks and savings and loan associations; and

WHEREAS, the County Commissioners desire the Treasurer to deposit such funds and monies in financial institutions located in the County; and

WHEREAS, CRS 24-75-601 to 24-75-603 provide for the investment of public funds and monies;

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF YUMA, STATE OF COLORADO:

- 1. The County Treasurer is hereby authorized to deposit County funds and monies in the following qualified local banks:
  - a. Bank of Colorado
  - b. Equitable Savings and Loan Association
  - c. First National Bank Kirk
  - d. First Pioneer National Bank of Wray
  - e. Wray State Bank
  - f. ColoTrust
  - g. CSafe
  - h. First Farm Bank
- 2. The County Treasurer is hereby authorized to invest County funds pursuant to the Treasurer's Investment Policy. The primary objectives of such investments shall be the safety of the invested funds and the liquidity of the invested funds for the timely payment of County obligations. The secondary objective shall be the achievement of a market average yield on the invested funds.
- 3. The Treasurer shall invest County Funds only in the following securities:
  - a. Money Market accounts and certificates of deposits issued by banks located in the County and collateralized under applicable Colorado statutes.
