



## **Proposition 120 (STATUTORY)**

Shall there be a change to the Colorado Revised Statutes concerning property tax reductions, and, in connection therewith, reducing property tax revenue by an estimated \$1.03 billion in 2023 and by comparable amounts thereafter by reducing the residential property tax assessment rate from 7.15% to 6.5% and reducing the property tax assessment rate for all other property, excluding producing mines and lands or leaseholds producing oil or gas, from 29% to 26.4% and allowing the state to annually retain and spend up to \$25 million of excess state revenue, if any, for state fiscal years 2022-23 through 2026-27 as a voter-approved revenue change to offset lost revenue resulting from the property tax rate reductions and to reimburse local governments for revenue lost due to the homestead exemptions for qualifying seniors and disabled veterans?

### City of Wray Question 2D

SHALL THE ESTABLISHMENT AND OPERATION OF MARIJUANA PRODUCT MANUFACTURING FACILITIES BE PERMITTED IN THE CITY OF WRAY, COLORADO. IF SUCH ESTABLISHMENT AND OPERATION IS APPROVED, SHALL THE CITY OF WRAY TAXES BE INCREASED BY \$500,000.00 FOR THE FIRST FULL FISCAL YEAR (2022) AND ANNUALLY THEREAFTER BY SUCH AMOUNTS AS ARE RAISED ANNUALLY THEREAFTER BY THE IMPOSITION OF A FIVE PERCENT (5%) EXCISE TAX ON WHOLESALE TRANSFER OR SALE OF MARIJUANA AND MARIJUANA PRODUCTS FROM OR TO A MARIJUANA BUSINESS WITHIN OR WITHOUT THE CITY OF WRAY, INCLUDING TRANSFERS BY THE SAME BUSINESS BETWEEN LICENSES, ASSESSED ON THE AVERAGE MARKET RATE OF UNPROCESSED MARIJUANA NOT FOR RETAIL SALE (FOR MARIJUANA) AND ON THE GREATER OF THE PRICE PAID BY THE PURCHASER OR THE CASH VALUE OF MARIJUANA PRODUCTS (FOR MARIJUANA PRODUCTS), WITH THE RATE OF SUCH TAX BEING ALLOWED TO BE DECREASED OR INCREASED WITHOUT FURTHER VOTER APPROVAL SO LONG AS THE RATE OF THE TAX DOES NOT EXCEED 15 PERCENT WITH THE RESULTING REVENUES FROM THE EXCISE TAX TO BE USED TO PAY OR REIMBURSE THE CITY FOR DIRECT AND INDIRECT COSTS INCURRED OR EXPENDED BY THE CITY RELATED TO THE REGULATION OF THE MARIJUANA PRODUCT MANUFACTURING FACILITIES AND FOR OTHER GENERAL PURPOSES OF THE CITY PROVIDING THAT IF ANY PORTION OF THE BALLOT ISSUE BE DETERMINED TO BE INVALID, THEN THE WHOLE BALLOT ISSUE WILL BE NULL AND VOID AND BE OF NO EFFECT; AND IN CONNECTION THEREWITH. SHALL THE FULL PROCEEDS OF SUCH TAXES AT SUCH RATES AND ANY EARNINGS THEREON BE COLLECTED, RETAINED, AND SPENT, AS A VOTER-APPROVED REVENUE CHANGE WITHOUT LIMITATION OR CONDITION, AND WITHOUT LIMITING THE COLLECTION, RETENTION, OR SPENDING OF ANY OTHER REVENUES OR FUNDS BY THE CITY OF WRAY UNDER ARTICLE X SECTION 20 OF THE COLORADO CONSTITUTION OR ANY OTHER LAW?
