YUMA COUNTY COMMISSIONERS December 30, 2021 Minutes¹

On December 30, 2021 at 8:00 a.m., the Yuma County Board of Commissioners met in regular session. Chairman Trent Bushner, Commissioner Robin Wiley, Commissioner Scott Weaver, and Administrator Andrea Calhoon were present throughout the day.

The Commissioners reviewed and signed accounts payable and discussed various meetings attended throughout the prior month.

Road and Bridge

Road & Bridge Supervisor Tom Andersen, Blade Foreman Justin Lorimer, and Truck Foreman Jeremy Lund joined the meeting at 8:30 a.m. to provide department updates.

- Landfill Work The group discussed dirt work needed at the Yuma County Landfill for expand a holding pond. Andersen will connect with the Landfill Manager to discuss and plan.
- Fuel Tanks Andersen provided updates on the installation of fuel tanks at the Wray shop. Andersen anticipates presenting bids for necessary electrical work at the next meeting.
- Road Reports Lorimer provided reports on current road work throughout the County including
 work filling holes on 38 north of Lindsey Crossing and then will move to County Road KK south of
 County Road 7 and to LL.5. After that, Lorimer expects the team will move back to SS. The
 group discussed options for water supply in the Hale area.
- Truck Orders Lund reported on the status and expected delivery of trucks ordered for 2021 and 2022. The 2021 trucks are built and at the dealership getting options installed and Lund expects they'll be picked up in the next month. Following delivery Lund will conduct training on the new digital features. The 2022 trucks are expected between May and August of 2022.

Human Services

The Board of County Commissioners convened as the Board of Social Services at 9:30 a.m. Human Services Director Kara Hoover and Receptionist Robin Stich were present. Detailed minutes of the Board of Social Services are maintained separately by the Department of Human Services. The Board of County Commissioners reconvened at 10:15 a.m.

City of Wray, James DePue

At 10:30 a.m. the Commissioners were joined by Wray City Manager James DePue to discuss regional transportation collaboration and potential funding partnership opportunities. The group discussed current State funding opportunities and the prioritization of the 385 corridor within the region.

Fair Queens, Michelle Smith

At 11:00 a.m. the Commissioners met with the Yuma County Fair Queens and Fair Queen Coordinators to hear program updates. Present were Michelle Smith, Kaci Porter, Grace Schaffner, and Shyla Hatch. The group discussed sponsorship efforts for the past year and the upcoming year and reviewed the upcoming schedule of events. The Queen team reviewed their plans and accomplishments with respect to program updates and goals. Smith submitted a current financial report and made the annual request for the Commissioner's contribution.


