YUMA COUNTY COMMISSIONERS January 30, 2023 Minutes¹

On January 30, 2023 at 8:00 a.m., the Yuma County Board of Commissioners met in regular session. Chairman Scott Weaver, Commissioner Mike Leerar, Commissioner Adam Gates, and Administrator Andrea Calhoon were present throughout the day.

The Commissioners initiated the meeting with the pledge of allegiance, reviewed and signed accounts payable, and discussed various meetings attended throughout the prior month.

Liquor Licenses

Deputy County Clerk Nancy Wright presented for signature the previously approved retail liquor license for Jo's Liquors.

Road and Bridge

Road & Bridge Blade Foreman Justin Lorimer joined the meeting at 8:30 a.m. to provide department updates.

- Bucket Truck Estimate Lorimer presented an estimate following the annual inspection of the bucket truck. Commissioner Leerar moved to approve the repair of the bucket truck by Aerial Equipment Specialists as presented. Commissioner Gates seconded the motion, which passed unanimously.
- Emergency Response Overtime Finance Officer Sarah Carwin joined the discussion to define
 parameters for paying overtime for emergency callouts and to discuss financial policies for when
 overtime would be paid in lieu of comp time. The Commissioners approved the payment of
 overtime for emergency response based on the recommendations made by Lorimer and Carwin.
- Summer Schedule Lorimer reported the return to 4 10-hour days effective February 20th. The group discussed overtime management and reaffirmed that the 4 10-hour week does not have set days of the week and will flex based on environmental needs and blading conditions. Commissioner Adam Gates moved to approve the summer Road & Bridge schedule to begin February 20th and end before Veteran's Day. Commissioner Leerar seconded the motion. It passed by unanimous vote.
- Road Report Lorimer discussed snow removal efforts and community response regarding weather response.
- Public Comment Allen and Trevor Zuege joined the meeting to issue public comment regarding road maintenance including concerns over what material is being used, personal maintenance of public roadways, and County liability in road maintenance. Commissioner Gates moved to approve Allen Zuege to lay down his own personally purchased material with his own equipment on the County Road near his house. Commissioner Leerar seconded the motion. Following discussion, the motion failed with Commissioner Gates voting in the affirmative and Commissioners Weaver and Leerar voting in the negative.

Human Services

The Board of County Commissioners convened as the Board of Social Services at 9:30 a.m. Eligibility Supervisor Dalene Rogers, Child Welfare & Adult Protection Supervisor Hollie Hillman, Bookkeeper Melanie Fisher and Human Services Director Kara Hoover were present. Detailed minutes of the Board of

Deputy County Clerk Pam Zuege joined the Commissioners at 11:00 a.m. to present information on the required upgrade to election equipment in 2023.

Wray Ballfield, Field of Dreams 2.0

At 1:30 p.m. the Commissioners met with Dave Wilson and Chad Godsey to discuss recent fundraising efforts to build new baseball/softball fields on the Wray High School campus through an organization called Field of Dreams 2.0. Status to date was given including updates on community meetings held, fundraising efforts, and community feedback received to date.

Property Taxation Bill Proposal, State Senator Byron Pelton

State Senator Byron Pelton cancelled attendance to discuss his proposed property taxation bill HB23-1054. The Commissioners met with County Assessor Cindy Taylor and Deputy County Assessor Carrie Sharp to discuss the bill's potential implications for Yuma County. Taylor and her team presented financial analyses of the bill's impact on revenues for Yuma County and for the taxing districts within Yuma County.

The group also briefly reviewed potential property tax implications for renewable energy projects in the County.

Executive Session

At 2:35 p.m. Commissioner Gates moved to enter into executive session under CRS 24-6-402(4)(b) for legal advice on specific legal matters. Commissioner Leerar seconded the motion, which passed unanimously. Executive session ended at 3:22 p.m. No action was taken following executive session.

WHEREAS, the Board of County Commissioners of Yuma County, State of Colorado has convened a duly and lawfully called regular meeting on the 30th day of January, 2023, and;

WHEREAS, the Board of County Commissioners recognizes and fully supports economic development in Yuma County, and:

WHEREAS, the State of Colorado has enacted the Rural Jumpstart Zone program (CRS 39-30.5-106) for the express purpose of encouraging economic development in rural areas of Colorado, and;

WHEREAS, the Yuma County Board of County Commissioners has determined that it is in the best interest of the County to participate in the Rural Jumpstart program;

NOW, THEREFORE, BE IT RESOLVED, the Commissioners of Yuma County, State of Colorado, authorizes Yuma County's participation in the Rural Jumpstart Program, and;

BE IT FURTHER RESOLVED, in the course of this participation, Yuma County does hereby agree to provide incentive payments, exemptions, or refunds, as appropriate, for 100% of the county business personal property tax imposed on all new businesses that are approved by the Colorado Economic Development Commission to participate in the Rural Jumpstart program, for as long as the Colorado Economic Development Commission designates these new businesses as approved for the Rural Jumpstart program, understanding that such tax relief is limited by statute to eight years for each new businesse.
