Information on the IGA was presented by Michael Snow. Drafted in 2016, a 100% vote by all RPC members is required in order the make any changes. Bylaws may be changed by those attending. All are to review the IGA and present any possible suggestions for changes by the first week in January. Commissioner Beedy recommended County Commissioners take the lead on engaging and encouraging municipal participation from within their County. TPR administration staff will present any change recommendations received at the next TPR meeting. Approval of MOA. Commissioner Hornung moved and Commissioner Hofmeister seconded the approval of the MOA with Yuma County as the Regional Administrator of the Eastern TPR. Motion passed unanimously.

Informational Items

CDOT staff presented and discussed grants, funding, eligibility, planning and upcoming projects. Highways 385 and 71 were discussed with possibilities to be viewed as part of the Freight Plan. Highway 385, north of Holyoke to Julesburg, projected to have repair work and shoulders extended. March/April 2023 is the projected start date for the project. Heather Paddock, CDOT Region 4 Transportation Director answered questions about highway 71 becoming an interstate. Joe Kiely, VP of Operation Ports-to-Plains added that a freight study needs to be conducted. Commissioner Hofmeister expressed concern over a recent statement by the Governor that he was unaware of discussion related to establishment a freight corridor in Eastern Colorado. Commissioner Beedy requested that the Eastern TPR be given a special meeting during the development of CDOTs upcoming long-range plan in the interest of re-instating local involvement in long-range planning. Commissioner Burgess expressed concern over missing signage on Highway 71 north of Limon that recently caused a fire department to miss their turn when responding to an emergency call.

An expression of gratitude was issued to Commissioner Trent Bushner for his contributions to transportation in the region prior to his impending retirement.
