OMNI is building evaluation plans for Colorado ROOTS' — the awardee for the Region's recent Treatment and Recovery RFP— as well as the local jails receiving funding for MOUD services.

Naloxone Bulk Purchase Fund

Lindsey Simbeye of Velocity BioGroup spoke about the changes to the Colorado Naloxone Bulk Purchase Fund. Region councils are able to use abatement funding to purchase naloxone in bulk.

Community organizations are asked to work together for purchasing and distributing Naloxone in their areas. Representatives from North Colorado Health Alliance, Advocates for Recovery Colorado and Centennial Mental Health Center do not expect the changes to impact them.
