COAC Infrastructure Share (Round 3)

Deadline: February 3, 2025

Purpose: The purpose of the Infrastructure Share is to promote capital improvements and provide operational assistance for developing and improving the infrastructure necessary to abate the opioid crisis in Colorado. The Infrastructure Share is further intended to meet the needs of rural and underserved populations.

Areas of Focus: Infrastructure

Eligibility: According to the MOU, eligible Applicants for the Infrastructure Share include: • Local governments that participated in the Colorado Opioids Settlement MOU1 • Colorado state agencies/state government entities • Colorado Regional Opioid Abatement Councils (ROACs), which were formed as a result of the MOU and have a Colorado governmental entity serving as the Fiscal Agent.

If multiple organizations are applying together, please select one entity to serve as the Applicant. Any additional entities should be listed as "Implementing Organizations." The primary Applicant should be the governmental entity or ROAC that will accept the terms of the Award Letter, receive the disbursed funds, be responsible for funds management, and submit the required annual Expenditure Reports.

Rural Health Care Program – Healthcare Connect Fund

Deadline: April 1, 2025

Purpose: The Healthcare Connect Fund (HCF) Program is a component program of the FCC's Rural Health Care Program. It provides funding to eligible healthcare providers for eligible expenses related to advanced telecommunications and information services necessary for the provision of healthcare. An eligible healthcare provider can apply individually or through a consortium.

<u>Examples of eligible products and services</u> include broadband services, network equipment, network security, and HCP-constructed and owned network facilities.

Areas of Focus: Infrastructure

Amount of Funding: The HCF Program provides eligible healthcare providers a flat 65% discount on eligible advanced telecommunications and information services.

Eligibility: A healthcare provider must meet the following criteria to be eligible:

- 1. Must fall under one of the healthcare provider categories listed below:
 - Post-secondary educational institutions offering healthcare instruction, including teaching hospitals and medical schools
 - o Community health centers and health centers providing healthcare to migrants
 - Local health departments and agencies
 - o Community mental health centers
 - Nonprofit hospitals
 - Rural health clinics
 - o Dedicated emergency departments in rural for-profit hospitals
 - Skilled nursing facilities
 - o A consortium of healthcare providers consisting of one or more entities described above

Application Process: The current filing window is December 1, 2024 - April 1, 2025.

Reaching Rural: Advancing Collaborative Solutions

Deadline: December 16, 2024

Purpose: Reaching Rural: Advancing Collaborative Solutions is a 1-year fellowship designed to help public safety and public health practitioners and other interested community members address substance use and misuse in rural communities. Participants will work to build deeper networks across sectors, adopt bold solutions, and reimagine how diverse systems can engage to better serve justice-involved individuals with substance use or co-occurring disorders.

Program activities include:

- Assess local or regional opportunities for systemic change
- Build leadership skills to facilitate cross-sector collaboration
- Explore the implementation of evidence-informed strategies in diverse rural settings
- Identify opportunities for different sectors, such as law enforcement, child welfare, prosecutors, probation, judges, public health, behavioral health, to align efforts more effectively
- Prioritize opportunities and strategies and commit to action
- Build a roadmap for local implementation and identify resources to support its implementation
- Commit to a project or individualized learning opportunity

Areas of Focus: SUD/rural

Amount of Funding: This is a fellowship opportunity. Participants will be reimbursed for travel and per diem costs when attending sponsored activities.

Reaching Rural fellows will have the opportunity at the end of the planning period to apply for an implementation grant of up to \$100,000 for up to 15 months to launch a project planned during the Reaching Rural fellowship

Eligibility: Eligible applicants are rural practitioners who work for:

- Local units of government
- Federally recognized Indian tribal governments
- Nonprofit agencies that work with a local unit of government or federally recognized Indian tribal government to respond to substance use or misuse issues and/or individuals with co-occurring disorders

Applicants may apply either as an individual practitioner or as a member of a cross-sector team. Cross-sector teams must consist of at least 4 people from 3 different sectors: justice or public safety, public health, and behavioral health. Teams may include up to 6 members maximum.

All proposed activities must exclusively target populations residing in <u>HRSA-designated rural areas</u> or areas designated as rural by a state or federal agency.

AmeriCorps VISTA Sponsoring Agency Request for Concept Papers

Deadline: December 6, 2024

Purpose: AmeriCorps VISTA is a program that provides resources and staffing for organizations and agencies working to alleviate poverty and address poverty-related problems in local communities.

AmeriCorps VISTA members are placed at sponsoring organizations, and serve for one year at approximately 40 hours per week addressing issues which have been locally identified as community priorities. The project goals and activities are designed to build the sponsor's capacity to serve low-income communities.

Priorities include:

- **Economic opportunity:** Housing, employment, workforce development, and federal benefit access
- Education: School readiness, K-12 success, career and technical education, and college access and success
- Healthy futures: Food security and access to healthcare, including preventive education, treatment/recovery services, and mental healthcare
- Veterans and military families: Economic opportunity, education, and healthy futures
- **Environmental stewardship:** Anti-poverty initiatives that focus on environmental stewardship and climate change in low-income communities
- **Priority populations:** Rural communities, areas of deep poverty, and native nations and tribal communities

Additional priority consideration will be given to projects that:

- Address racial equity
- Invest in underserved communities, especially those impacted by long-term recovery from the COVID-19 pandemic

Areas of Focus: Workforce

Amount of Funding: For placed VISTA members, the program provides a modest living allowance depending on the county in which the VISTA serves, travel/relocation costs, health benefits, and childcare benefits if eligible.

Eligibility: Eligible VISTA sponsors include:

- Nonprofit organizations
- Native nations and native led organizations

- Public and nonprofit schools
- State and local government agencies

Colorado Community Initiated Solutions Grants

Deadline: February 15, 2025; June 15, 2025

Purpose: The Colorado Health Foundation provides funding for projects that directly engage community members to identify health challenges and implement solutions that meet the specific needs of their communities.

Organizations are required to work collaboratively with community members to:

- Address a health challenge
- Develop and implement a solution
- Leverage existing strengths and resources
- Improve health equity

Priority will be given to projects that advance health equity or that center on communities of color.

Areas of Focus: Community Health

Amount of Funding: Not stated

Eligibility: Eligible applicants include:

- Community based groups or nonprofit organizations with 501(c)(3) status
- Organizations that can demonstrate a substantial commitment to community-identified and community-led efforts to address complex health-related issues and/or challenges

Organizations without 501(c)(3) status may apply through a fiscal sponsor.

Medications for Opioid Use Disorder (MOUD) Training and Mentoring

Deadline: Applications accepted on an ongoing basis

Purpose: This program provides free training and mentoring services for eligible healthcare providers to effectively use buprenorphine and other medications to treat opioid use disorder (OUD) in high-need communities. Completion of the training will count toward meeting MATE Act training requirements for practitioners registering for or renewing a DEA license. The training is free to complete, and is available in-person or online. The MD/DO training course is 8 hours, and the courses for nurse practitioners, physician assistants, and other advance practice nurses are 24 hours.

Areas of Focus: Treatment

Amount of Funding: The course is provided at no cost to eligible clinicians.

Eligibility: Eligible participants have an active Drug Enforcement Administration (DEA) number to dispense controlled substances and are one of the following:

- Physician (MD or DO)
- Nurse practitioner (NP)
- Physician assistant (PA)
- Certified nurse-midwife (CNM)
- Certified registered nurse anesthetist (CRNA)
- Medical students
