# Opioid Response Region 4 Council Agenda August 4, 2025 10:00 a.m. Virtual Meeting Attendance

On August 4, 2025, at 10:00 a.m., Board members, Advisory Council members, vested partners, community members from across the Eastern District, and staff from the Colorado Attorney General Opioid Response Unit attended a virtual meeting to continue the work of the Regional Opioid Abatement Council (ROAC).

#### **Minutes**

Mike Brownell moved to approve the July meeting minutes. Terry Hofmeister seconded. The motion passed without objection.

## Financial Reports

Brandi Ritchey shared the current Region 4 financial update. The Council reviewed funding to date and current funding areas.

Dave Martin moved to approve the June financials. Mike Brownell seconded. The motion passed without objection.

#### Review of Funding Available and Committed for the Region

Omni shared the Region's current funding, including dollars available in accounts, allocated to Region 4 available from the State, current unallocated dollars, and future years' estimates.

Terry Hofmeister clarified that interest on these funding dollars goes back into abatement funding, not to any entity. The Council discussed potential gaps in services that funding can

assist with, such as residential/sober-living housing, inpatient services, and brick-and-mortar spaces, especially in rural areas. Melissa Memorial Hospital was highlighted as a partner in the Council's work and rural hospitals in general that may be concerned about funding in the future.

### **Omni Evaluation Updates**

Omni shared the Quarter 4 evaluation report on medications for opioid use disorder (MOUD) services in Region 4 jails. The report discusses the number of individuals who received MOUD and demographic information.

The report is posted to the Region 4 website.

### **Funding Continuation for MOUD in Jails**

Omni reviewed that \$100,000 was initially set aside for MOUD funding, with over \$5,000 spent. The Council discussed the impact of the fund from the Sheriff's Office and pharmaceutical perspective. Since there was no opposition, the Board decided to continue funding for MOUD in jails and evaluation supported by Omni.

### Purdue and Generic Opioid Manufacturer Settlement Participation Discussion

Omni shared that emails were sent to local governments last month for the Purdue and Generic Opioid Manufacturer Settlement. Local governments are encouraged to respond to participate again.

#### **Newly Funded Entities Overview**

Omni shared information on newly funded organizations. Colorado ROOTS received Infrastructure Funding from the Colorado Opioid Abatement Council (COAC). With the new Region 4 funding round, grantees shared the proposed work from Antelope Recovery, The Naloxone Project's Buprenorphine Field Induction Program, North Colorado Health Alliance, and Hope House of Eastern Colorado.

## **Spotlight Presentation**

MJ Jorgensen shared NCHA's goals and progress under the current Infrastructure Funding. In the past 1.5 years, NCHA has increased partnerships, outreach, and awareness, and shared the impact via social media platforms. NCHA has also utilized different methods to distribute 4,496 naloxone kits and 8,992 doses. NCHA will continue their work for the remaining funded period.

### **Member Norms and Expectations Review**

Omni reviewed norms and expectations for Council Members and Advisory Members. Board members are encouraged to evaluate capacity for participation for later discussion.

#### **Grants Updates**

Omni shared that the Board provided letters of support for three (3) organizations – NCHA, Colorado ROOTS, and Clear Path Recovery – looking to apply for the Signal 1287 funding.
